Terms and Conditions for Renewal of Registration of Child Care Institutions in Karnataka

1. This Certificate is non-transferable and subject to immediate return to the Registration Authority in the event of closure of the organization (It will have no effect from the moment of withdrawal of renewal of registration)
2. Any change of address of the organization / Institution shall be intimated to the Registration Authority.
3. It shall scrupulously follow: (1) JJ Act 2015 as amended Act in 2021, JJ Model rule 2016 as amended in 2022, Adoption regulations and mission vatsalya implementation guidelines.
4. The organisation shall maintain all necessary Records / Registers and documents as per the Juvenile Justice (Care and Protection of Children) Model Rules, 2016 as Amended in 2022.
5. The organization shall be subject to inspection by the District Magistrate, officers of the District of child protection and WCD or by any Inspection committee appointed / approved by the state Government.
6. This registration certificate does not authorise the organization to deal with adoption for which separate recognition as per Adoption Regulations, 2022 shall be obtained from state Government
7. This Certificate along with conditions shall be displayed in a conspicuous place in the Office of the Organization.
8. The Registration of the organization shall be renewed once in every five years
9. The Organization shall obtain renewal before the expiry of the validity period
10. The registration shall be liable to be withdrawn if the Registration Authority receives complaints of any malpractice / improper functioning / misuse of funds / poor quality of care and services to children
11. Details of all the children in the Organization shall be submitted to the DCPU, CWC, JJB and Director, Directorate of Child protection as per the JJ act 2015 as amended in 2021, JJ model rules 2016 as amended in 2022.
12. It shall abide by the directions issued by the State Government from time to time
